- Equitable Development
 - Share a few takeaways from the association's recent community meeting titled "Pathways to Community Ownership: Economic Justice at 38th Street and Beyond." Note the guest panelist were Jimmy Lloyd with Pillsbury United Communities - Justice Built Communities, and Elwood Hopkins -Presidential Fellow with the Kresge Foundation. He published a recent article in the Stanford Social Innovation Review titled "Building an American Ownership Society"
 - b) Highlight PPNA's staff involvement in a learning cohort led by the Local Initiatives Support Corporation (LISC) Twin Cities that helped provide more insight into the process for structuring Community Investment Trusts. The insight that staff continues to amass about ways to help facilitate community ownership will result in a few scenarios recommendations to the Board by the end of third quarter
 - c) Provide update on staff efforts to partner with members of the Lake Street Leadership Recovery Coalition (LSLRC) to quantify and describe the types of strategies and funding needed to aid equitable and healthy development along and near cultural corridors impacted by the civil uprising in response to the heinous murder of George Floyd.

3. Livability & Safety

- a) Share some of the key insight provided during recent meetings related to improving safety and livability within the City. This includes the April 7th SMPSC Town Hall that featured Chief Arradondo, and Commissioner Gretchen Musicant of the City's Health Department. The updates will also be informed by a meeting that included members of SMPSC that took place with the Commissioner on April 29th.
- b) A key takeaway from both conversations is the variety of programs and services that are aimed at crime prevention that aren't adequately connected at the moment. This also seems like a need various City representative are unsure how to improve at the moment.
- c) Highlight early learnings from a conversation with emerging partner Unidos MN. They inquired about the association's interest in having some degree of program oversight for "certified community security personnel." They were representing a group called Lake Street Rise Up, and its Community Security Services sub team. I had a substantial number of questions that require more follow up to better understand what role PPNA is being asked to provide, and have funding already been raised for this new initiative.

4. Housing Justice

- a) Currently, the various housing centered coalitions that PPNA support are extremely concerned by the prospect of the eviction moratorium being lifted in the State, without adequate resources being made available to those who are "behind" on rent. Based on recent ACS data, there is an estimated 15,000 households who have rental arrears in Hennepin County.
- b) There are a variety of proposed renter protections that have stalled at this City. Some of this is due in large part to a recent decision by U.S. District Judge Paul Magnuson who granted a preliminary injunction to stop enforcement of a suite of St. Paul renter protections known as S.A.F.E [Safe, Accessible, Fair, & Equitable]. As a result, the City's Attorney Office has advised lawmakers to somewhat suspend further planning to advance ordinances like TOPA, and Right to Cure until the final opinion is issued in the St. Paul case.
- c) Grace is working to help communicate our understanding of the core arguments for and against some of the various tenant protections that the Board has already voted to help advance. These communications across the broader community aim to help build further awareness, clarity, and concern for no action being taken to support renters.
