City of Minneapolis | Rent Stabilization Efforts | Grace Berke

20 MINUTES 1. Background & Updates

- A. Provide insight into the public and private groups taking steps to advance and support a rent stabilization policy with the City of Minneapolis. In various circles, tools like these have also been referred to as rent control.
- B. Outline several core factors that are influencing the City's approach, this includes:
 - a) The state pre-emption that currently sets limitations or guidelines around what steps a municipality must first take to enable a rent stabilization ordinance to be implemented.
 - b) Based on City Attorney advice, and interpretation of the State statue, the City is looking to advance two separate Charter Amendments that would create the possibility for establishing a rent stabilization policy in 2022.
- C. Describe staff recommendation related to ways PPNA can help the community understand and discuss rent stabilization. Presently, this tool is seen as an extension of other ordinances and controls the City Council and City Enterprise have already enacted to support access to affordable rental units. This includes ordinances like Inclusionary Zoning, Advance Notice of Sale, and its current efforts to pass a Tenant Opportunity to Purchase Agreement (TOPA) ordinance in 2021.

Proposed Public Notice Amendment | Tabitha Montgomery

1. Overview

- A. Based on a conversation with Paul Mogush, Planning Manager in CPED, we have come to understand that Public Notice related to a hearing by the City Planning Commission (CPC) are only sent to property owners. This was the primary reason that renters living at the 3251 14th Ave. S. property were unaware of the public hearing surrounding Touchstone Mental Health's Conditional Use Permit (CUP) application.
- B. There is an opportunity for PPNA to take steps to get this ordinance amended so that renters, as well as property owners, receive Public Notices related to applications under review by the CPC.

A. Review some of the brand materials and web pages connected to the Racial Equity & Community Health (REACH) Twin Cities initiative that PPNA is helping to drive in partnership with more than a dozen other community partners. This work is part of efforts being supported by the Lake Street Leadership Recovery Coalition (LSLRC)

3. Livability & Safety

- A. Meeting with OVP & CM Cano (2/11) Provide summary of updates captured in meeting with Sasha Cotton, Director of the Minneapolis Office of Violence Prevention (OVP). The meeting was initiated by several members of the South Minneapolis Public Safety Coalition (SMPSC). This group is planning to host a community meeting in March related to the City's preparedness to approach community safety differently and with additional resources allocated in the 2021 City budget.
- B. Community Planning: George Floyd Murder Trial & Anniversary of his Murder (2/6) PPNA, along with more than three dozen representatives from the community or other local organizations, participated in a meeting convened by the Racial Agency Initiative (RAI) to discuss the various plans that community members are making to show solidarity to the calls for justice as the trial start. And as it relates to the various memorial celebrations that will take place on and around the anniversary of Mr. Floyd's murder. RAI is owned and operated by the Lead Caretaker for George Floyd Square, Jeannelle Austin. The aim of the meeting was not centered on consolidating efforts but to increase awareness so folks can partner and support each other's efforts as feasible. A few key take-aways:
 - a) PPNA will partner with nearby neighborhood organizations to help share and promote Tier 1 safety strategies to residents leading up to the trial. This will focus on practical ways individuals and households can help support community safety during the trial.
 - b) Organizer associated with Save the Boards and Visual Black Justice are partnering on facilitating a direct action near the courthouse that will take aim at encouraging the police department and the defendants to reflect on their actions, while showing support for Mr. Floyd's family as they enter.
 - c) Leaders at Calvary Lutheran Church, located at 3901 Chicago Ave. S., are working to organize a Prayers for Justice call to action on the first day of the trial. It's my understanding that this call to prayer will have a non-denominational focus.
 - d) One of the discussed in memorial celebrations is being organized by a group of black theater artists and allies. They are planning to host an event called "Black is...Arts Festival & March" that will take place over a five-day period between May 21st May 25th. More info to come.
